This Form 4 reports the grant of 63,000 shares of restricted stock under the Spartan Stores, Inc. 2001 Stock Incentive Plan ("Plan"). Prior to vesting, these shares will remain subject to restrictions in accordance with the Plan and the terms of the grant.
