(1) The option vests in four equal annual installments beginning on February 10, 2012.

These goals are based on Company performance against an established industry benchmark, over a three year performance period. The final award of shares issued can be between 0% and 200% of the target award.

(3) Each restricted stock unit represent a contingent right to receive one share of Company common stock.

(4) The restricted stock units vest in four equal annual installments beginning on February 10, 2012.

(5) The option vests in four equal annual installments beginning on December 12, 2003.

(9) The option vests in four equal annual installments beginning on December 8, 2005.
